

# JD Flex Track

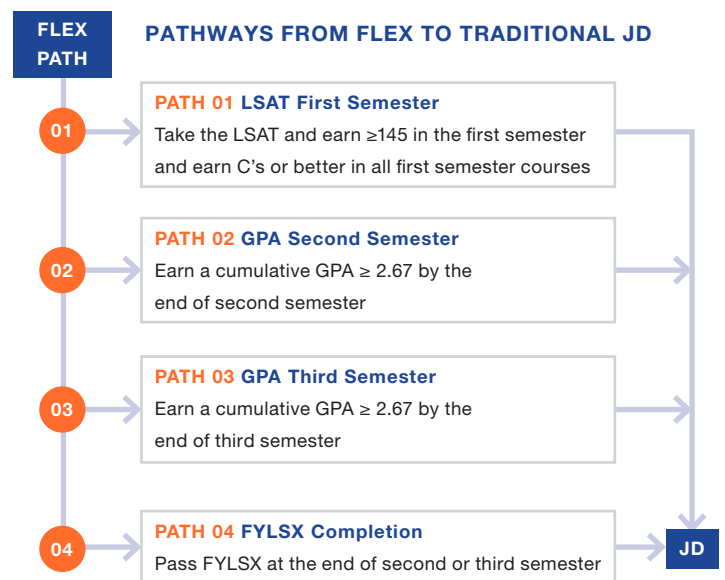
## 2025-2026



### Academic Program

To fulfill our commitment to making legal education accessible, we offer an academic support structure called the Flex Track. This program allows students to attend law school when they demonstrate an aptitude for success but either did not take the LSAT or did not receive a score of at least 145 on the LSAT.

Flex Track students, who are part-time, must adhere to a predetermined class schedule for their initial two semesters. After the second semester, those who do not achieve a GPA of 2.67 or higher, score at least 145 on the LSAT during the first Flex semester, and earn at least a C in each course are required to pass the First-Year Law Students' Examination (FYLX) to continue in the Regular JD program. Alternatively, to continue in the Regular JD program, students not dismissed may continue for an optional third semester of study but must earn a cumulative GPA of 2.67+ or pass the FYLX.



### WHAT IS THE FYLSX?

The First-Year Law Students' Examination (FYLX) is a one-day exam offered by the State Bar of California that tests your knowledge of typical first-year law classes (Torts, Contracts, and Criminal Law) through multiple-choice and essay questions. ### HOW MUCH DOES FLEX TRACK COST?

Tuition for the 2025-2026 Academic Year is \$1,075/unit. The first year of Flex Track tuition, plus fees, is \$21,050. This includes Academic Support service fees of \$850 each semester in which the student participates in Flex Track. The support fees provide Flex students with access to Barbri 1L Mastery materials, Adaptibar MBE access for one year, 1:1 Tutoring session and Academic Advisement meeting, Group tutoring sessions, and Fleming's Fundamentals of Law First-Year Law School Examination preparation materials. Federal financial aid is available.

### WHAT IS REQUIRED TO BE CONSIDERED FOR FLEX TRACK?

Students must generally take the LSAT and receive a score of 145 or higher to be admitted to the JD program. Those who do not have an LSAT score of at least 145 (including applicants who have not taken the LSAT) may be admitted to the JD program if the applicant demonstrates other indicia of success. Due to the strong correlation between LSAT scores and success in law school, any applicant who is accepted without an LSAT score of 145 or higher must participate in Flex Track academic support.

### WHAT IF I HAVE NOT TAKEN THE LSAT?

Applicants who have not taken the LSAT will be considered for admission, but the quality of other application components will be emphasized.

All required courses are offered either on campus in the evenings or 100% online. You may select a hybrid schedule as well, with some classes online and others on campus. The third semester is exclusively conducted in an online format.

## WHAT WOULD MY ONLINE SCHEDULE LOOK LIKE?

The majority of online Flex coursework is completed independently by the student with weekly deadlines, which allows for great flexibility in scheduling law school study. Live sessions via video conferencing are required at specific times. Live sessions ensure that information studied independently is sufficiently comprehended. Attendance at live sessions is mandatory. These live sessions are typically held on weeks 1, 2, 3, 4, 6, 10, 12, and 14 of the semester for 2 hours, and generally begin at 6:00 pm Pacific / 7:00 pm Mountain / 8:00 pm Central / 9:00 pm Eastern Time.
