

SCHOLARSHIPS 2025-2026

MERIT-BASED

Dean's Full-Tuition + Stipend

A limited number of full-tuition scholarships are offered by Trinity Law School to qualified students of high academic caliber and personal excellence who seek to serve in the practice of law.

- 100% Tuition Scholarship (\$32,250 value) + \$500-\$1500 monthly stipend
- Must have LSAT score in 60th percentile or higher (approximately 156-180).
- Must be enrolled in 12 or more units per semester (30 units per year) and maintain a cumulative GPA of A- (3.5). Cannot be combined with any other scholarship.
- Scholarship is reviewed for GPA requirement every semester.

Dean's Full-Tuition

A limited number of full-tuition scholarships are offered by Trinity Law School to qualified students of high academic caliber and personal excellence who seek to serve in the practice of law.

- 100% Tuition Scholarship (\$32,250 value)
- Must have LSAT score in 50th percentile or higher (approximately 153-155).
- Must be enrolled in 12 or more units per semester (30 units per year) and maintain a cumulative GPA of B+ (3.3). Cannot be combined with any other scholarship.
- Scholarship is reviewed for GPA requirement every semester.

Dean's

This Scholarship is awarded to incoming law students based upon academic excellence and LSAT performance. To be considered for this academic scholarship, recipients must place within the top 25 percent of accepted students for the matriculating class.

- 50-75% Tuition Scholarship (\$16,125 - \$24,187 value)
- Must have LSAT score in 40th percentile or higher (approximately 151-152).
- Must be enrolled in 12 or more units per semester (30 units per year) and maintain a cumulative GPA of B+ (3.3). Cannot be combined with any other scholarship.
- Scholarship is reviewed for GPA requirement every semester.

Justice

This scholarship is awarded to incoming students based upon academic excellence and LSAT performance. To be considered for this scholarship, student's previous academic performance will weigh heavily in combination with their LSAT score to provide financial assistance for students who show potential to have a high academic performance at TLS. It is possible to have this renewed beyond the first year if specific academic requirements are maintained.

- \$5,000 - \$7,500
- Must have LSAT score in 33rd percentile or higher (approximately 149-150).
- Must be enrolled in 12 or more units per semester (30 units per year) and maintain a cumulative GPA of B (3.0). Cannot be combined with any other scholarship.
- Scholarship is reviewed for GPA requirement every semester.

Legal Studies

This scholarship is awarded to incoming students based upon academic excellence and LSAT performance. To be considered for this scholarship, student's previous academic performance will weigh heavily in combination with LSAT score to provide financial assistance for students who show potential to have high academic performance at TLS. It is possible to have this renewed beyond your first year if you maintain specific academic requirements.

- \$2,000 - \$5,000
- Must have an LSAT score in 26th percentile or higher (approximately 146-148).
- Must be enrolled in 12 or more units per semester (30 units per year) and maintain a cumulative GPA of B (3.0).
- Scholarship is reviewed for GPA requirement every semester.

These scholarships are for new students and students transferring in good standing. Dismissed students do not qualify. The decision of which scholarship given is ultimately determined by LSAT percentile, NOT score.

NON-MERIT BASED

Christian College

Trinity Law School offers a scholarship worth 50 percent of the cost of tuition for the entire three-year law school degree to any graduate from a regionally accredited Christian college or university that is a member of the North American Coalition for Christian Admissions Professionals (www.NACCAP.org), and that meets the requirements for admission to Trinity's regular JD program. This scholarship is also applied to the employees, and immediate family members of the employees, at these universities.

- 50% Tuition Scholarship (\$16,125 value)
- Meet the LSAT requirements for admission into Trinity Law School's regular program.
- Must maintain a cumulative GPA of B (3.0), and enroll in 12 or more units per semester (30 units per year). May be combined with other non-merit-based scholarships, except EV Free.

Evangelical Free Church

Trinity Law School is part of the Evangelical Free Church of America. Due to this affiliation, as a voluntary service to the EFCA, Trinity Law School offers a scholarship worth 50 percent of the cost of tuition for the entire three-year law school degree to the following: members of the EFCA churches for at least one year, employees of any of the EFCA churches, and immediate family members of full-time employees. Candidates must also meet the requirements for admission into Trinity's regular JD program.

- 50% Tuition Scholarship (\$16,125 value)
- Meet the LSAT requirements for admission into Trinity Law School's regular program.
- Must maintain a cumulative GPA of B (3.0), and enroll in 12 or more units per semester (30 units per year). May be combined with other non-merit-based scholarships, except Christian College.

Founder's

This scholarship honors the vision of Dr. John Warwick Montgomery, a renowned historian and lawyer, Dr. Harold Lindsell, a well-known theologian, and Dr. Walter Martin, a celebrated Christian apologist who desired to integrate law, human rights, and Christian apologetics into a single academic institution by the founding of Simon Greenleaf University. Trinity is proud to continue this vision by awarding scholarships to students who demonstrate the desire to integrate law and theology.

- \$1,500 maximum annually
- Meet the LSAT requirements for admission into Trinity Law School's regular program.
- Must maintain a cumulative GPA of B (3.0), and enroll in 12 or more units per semester (30 units per semester). May be combined with other non-merit-based scholarships.

Mephibosheth

The Mephibosheth Endowed Scholarship Program is provided by the late Peter DeKorte of Hawthorne, New Jersey. Mr. DeKorte, a successful businessman who had a disability, established this scholarship fund for Trinity Law School out of gratitude to the Lord for all He had done for him. Recipients of this scholarship must have a physical or sensory impairment that is likely to continue indefinitely. Recipients may be eligible for renewal each year if they maintain specific academic requirements. Preference will be given to those who have an impairment that makes employment during the academic year less likely.

Public Service Grant

The Public Service Grant is awarded to first-year law students demonstrating a commitment to public and community service. Examples of grant recipients may include pastors and their families, law enforcement personnel, as well as applicants with significant volunteer involvement in the community.

- \$500 maximum annually
- Meet the LSAT requirements for admission into Trinity Law School's regular program.
- Must maintain a cumulative GPA of B (3.0), and enroll in 12 or more units per semester (30 units per year). May be combined with other non-merit-based scholarships.

Community College Grant

These grants are awarded to AA or AS graduates and employees of California community colleges who have not yet earned a Bachelor's degree and who are beginning their first year of law study.

- \$2,500
- Apply and enroll in Trinity Law School's regular program with only an Associates Degree.
- Offered during your first year.

Church Match

If a church donates funds toward your education, Trinity Law school will match the donations each academic year.

- Trinity Law School will match up to \$1,000 annually for contributions given by any church; up to \$2,000 for contributions given by the Evangelical Free Churches, and up to \$2,000 for Trinity alumni per academic year. Offered during your first year.
- Meet the LSAT requirements for admission into Trinity Law School's regular program, and have a completed application from your church pastor validating source of funds.
- Must maintain a cumulative GPA of B (3.0), and enroll in 12 or more units per semester (30 units per year) for Trinity Law School to match donated amounts. Not valid for summer semester. May be combined with other non-merit-based scholarships.
